


### Health and Welfare

1. This kitten is purchased as a desexed pet
2. If it is necessary to rehome this kitten for any reason the purchaser is asked to first notify the seller and offer the kitten/cat to the seller.
3. This kitten/cat will be kept safe, either indoors, or if outdoors, in a safe secure – sheltered yard that the cat cannot escape from or under personal supervision and control or when being transported in a suitable pet carrier.
4. This kitten/cat will be well cared for, kept in a clean pleasant environment, with access to comfortable living quarters, health care and friendly companionship, quality, sufficient and appropriate nutrition, clean water and toileting facilities, and adequate space to play and exercise.
5. The buyer accepts responsibility to care for and agrees to seek veterinary care if the kitten or cat is sick or injured.
6. It is recommended the kitten or cat has a regular annual veterinary health check-up.
7. Under no circumstances will this cat/kitten be declawed, be sold, leased or given away to any pet shop, research laboratory or similar facility.
8. If this kitten is found to be neglected, mistreated or confined in unhealthy substandard conditions, the purchaser will surrender this kitten/cat to the breeder unconditionally at no charge.

### Health Guarantee

9. This health guarantee is valid for a period of 14 days from the purchase date.
10. This kitten has been checked by a licensed veterinarian to be in good health, currently vaccinated, treated for parasites and free of fleas, ear mites and worms at the time of sale.
11. It is recommended that the kitten be quarantined (kept away from other cats) during the initial settling in period.
12. If the kitten shows signs of lethargy, illness or distress the purchaser is responsible to seek and provide immediate care from a licensed veterinarian.
13. The health guarantee will be deemed null and void if the buyer fails to provide proper veterinary care or if the kitten is exposed to a cat or kitten suffering from an infectious condition.
14. If during the guarantee period (within 14 days of purchase) the kitten is diagnosed with an infectious disease the kitten may have been incubating when in my care **or** a congenital defect (within 1 year of purchase) that is an untreatable life threatening condition it **must** be reported to the seller **immediately**.
15. **Under no circumstances is the cat/kitten to be euthanized - put to sleep - destroyed - prior to notification by the buyer to the seller.**
16. God forbid - If this kitten dies within the guarantee period despite appropriate treatment, on receipt of a veterinarian's report of care given and a veterinarian's certificate certifying the cause of death and at the discretion of the breeder a replacement kitten will be made available of equal value. If a replacement is not available at that time the seller will have 12 months to provide a replacement.
17. The seller's guarantee and responsibility shall not extend to health matters wholly arising from the actions of the purchaser.
18. No cash refunds will be given.
19. A 6wk pet plan insurance is provided with this kitten.
